Debit Card Service Terms and Conditions

In consideration of Afghanistan International Bank (the bank) pursuant to my request, making available to me, Automated Teller Machine (ATM) facilities and issuing to me a Debit Card (the Card). I agree to be bound by the following Terms and Condition.

1. At no time to use or attempt to use the card unless there are sufficient funds in my account to cover the withdrawal.
2. Not to use or attempt to use the card after any notification of its cancellation or withdrawal has been given to me by the bank or any person acting on behalf of the bank.
3. To restrict use of the card exclusively to me as it is not transferable.
4. At no time and under no circumstances to disclose to any person the Personal Identification Number (PIN) allotted to me to facilitate the use of the card.
5. To immediately notify the bank of the loss or theft of the card.
6. To accept full responsibility for all transactions processed from the use of the card except any transactions occurring after the bank shall have confirmed to me that it has received notice of loss or theft of the card or of unauthorized acquisition of the PIN.
7. Subject to (7) above, to accept the bank's record of withdrawals as conclusive and binding for all purposes and to authorize the bank to debit my account with all amount withdrawal with or without my knowledge or authority.
8. To acknowledge that the amount stated on the ATM screen or a printed enquiry slip or receipt advice shall not for any purpose whatsoever be taken as conclusive of the state of my account with the bank.
9. Not to hold the bank liable, responsible or accountable in any way whatsoever for any loss, injury or damage howsoever arising caused by any mechanical defect in or insufficiency of funds in or malfunction of ATM / POS.
10. Notwithstanding and without prejudice to the generality of the provisions of (10) above, the use of the card shall be at my sole risk and I assume any and all risks incidental to or arising out of the use of the card.
11. That the bank will not be responsible for the card for any reason not being honored.
12. To return the card for cancellation should it be no longer required or should my account with the bank for any reason be closed.
13. That the bank shall be at liberty to terminate the facility at any time without notice to me by cancelling or refusing to renew the card.
14. I acknowledged that the bank has the right to vary these Terms and Condition, fees/charges etc. without giving any prior notice in writing to me.
15. We undertake to abide by the requirements of the prevention of money laundering Act/Policy in force.
