I, the undersigned, hereby declare that I wish to obtain an AIB Internet MasterCard Web Surfer Card "account" issued by Afghanistan International Bank, subject to all the applicable Laws of Afghanistan and the following conditions:

The card "account" is valid only for use on the internet and no embossed card shall be issued to the cardholder. A reference device, containing the account number, expiration date, CVC2 and the issuer name shall be delivered to the cardholder either physically or via email. Attempted use of the account outside the worldwide web shall be considered as a fraudulent use of the account, resulting in the automatic and immediate cancellation of the account. Face to face, Retail Merchants, ATM or Cash Advance transactions shall not be approved, authorized, or honored on this card.

The account is a prepaid account with no additional credit facilities being granted on it. The original amount shall be deposited by the cardholder into the account at the issuing bank, and shall be depleted by the transactions posted on, and charged to the account. The cardholder may periodically deposit funds at any AIB branch in order to reactivate the account. The cardholder shall be fully responsible for any and all the transactions on the account, whether authorized by the cardholder or not. The cardholder shall have no recourse or charge back right regarding disputed transactions appearing on the account, even if not authorized by the cardholder. The cardholder shall not receive a statement at the end of the month; however the cardholder can review & request statements, by logging on to the relevant site.

It is understood that such statement is free of charge. The reference device and the account remain the property of the issuing bank which reserve the right to withdraw or cancel it at any time, or refuse to renew the card, with no obligation to indicate or justify the action. Upon the expiration date indicated on the reference device, the account shall be automatically renewed for an additional year and the subscription fees then in force shall be automatically charged to the account, unless the cardholder notifies the issuing bank to the contrary, at least three months prior to the expiration date. The account will normally be accepted by all internet sites displaying the MasterCard logo and accepting international cards for payment of their goods or services.
